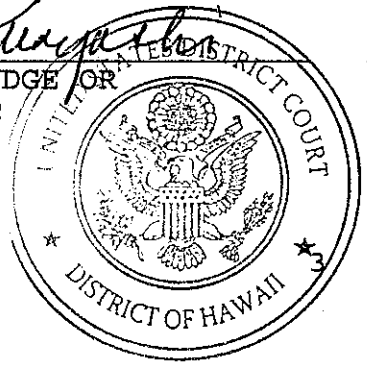

TO: Special Agent Steven P. Carter and any Authorized Officer of the United States.

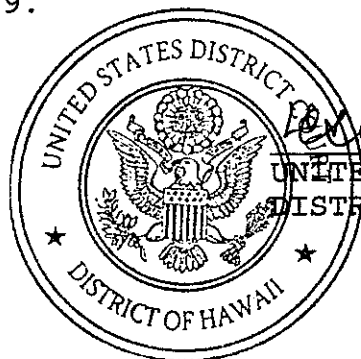
